



## **VOLUNTEER RELEASE AND WAIVER OF LIABILITY**

The volunteer Release/ waiver of Liability (the “release”) is made and entered into between the undersigned and Dr Doghouse Bully Crew Rescue effective as of the below-indicated date. The undersigned desires to volunteer with Dr Doghouse Bully Crew Rescue, and as an inducement to Dr Doghouse Bully Crew Rescue to agree to volunteer, the undersigned hereby represents, acknowledges and agrees as follows:

- 1) I acknowledge that, due to the unpredictable nature of animals, certain risks and dangers may occur while handling an animal, including but not limited to risks of injury to person and property, and that I have voluntarily agreed to handle the dogs in the capacity of a volunteer with Dr Doghouse Bully Crew Rescue herein with full knowledge of such risks and hereby voluntarily assume all of such risks.
- 2) I agree that I will not make any claims against, sue or attach any property of Dr Doghouse Bully Crew Rescue, its directors, officers, employees and/ or volunteers for any injury or damage caused by any animal(s) cared for by Dr Doghouse Bully Crew Rescue.
- 3) I hereby voluntarily release, discharge, waive and relinquish any and all actions or causes of action, for personal injury, property damage or wrongful death occurring to me or third parties as a result of any action or activity of any animal(s) cared for by Dr Doghouse Bully Crew Rescue. However, the same may occur which I may have against Dr Doghouse Bully Crew Rescue or any of its directors, officers, agents, employees or volunteers. whether the same shall arise by the negligence of said persons or otherwise. IT IS MY INTENTION BY THIS INSTRUMENT TO EXEMPT AND RELIEVE DR DOGHOUSE BULLY CREW RESCUE FROM ALL LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR OTHERWISE.
- 4) I hereby agree to hold Dr Doghouse Bully Crew Rescue and its directors, officers, agents, and/ or employees harmless and indemnify them from and against any liability, claims, judgements or expenses I may incur arising out of my handling or any other activities with an animal from Dr Doghouse Bully Crew Rescue.
- 5) I HAVE CAREFULLY READ THE FORGOING AND I UNDERSTAND THAT TOGETHER THEY CONSTITUTE A DISCLAIMER OF LIABILITY BY DR DOGHOUSE BULLY CREW RESCUE AND A RELEASE OF ALL CLAIMS BY ME. I UNDERSTAND THAT I ASSUE ALL RISKS INHERENT IN MY DECISION TO

VOLUNTEER WITH DR DOGHOUSE BULLY CREW RESCUE. I VOLUNTARILY SIGN BELOW TO EVIDENCE MY ACCEPTANCE OF THE ABOVE PROVISIONS.

- 6) If any portion of this release is held invalid, it is agreed that the balance hereof shall continue in full legal force and effect.
- 7) This release is governed by the laws of the State of California applicable to agreements entered into and fully performed therein.
